Secretary – Pattie T: Pattie submitted the March 29, 2021 minutes for review and approval; Dan P. requested the minutes be amended to reflect his attendance last month. Pattie then asked that the minutes be approved, as amended. Nancy made the motion to approve as amended, Marilyn R-D seconded and the vote carried.

Treasurer – Michael W: Michael will have March and April reports read and approved at the May IG meeting.

Special Events – NEEDS A CHAIR

Website Chair – Sandy: The Events are currently updated on the website. Sandy thanked Diane for preparing the Letter to Families and Letter to Professionals for the website.

Public Events – Diane: Diane is working on getting formats and the QR code. She wants to start a new campaign called Sponsor Your Doctor. She'll have more to report next month.

Footnotes Blog - Stacey F: Not in attendance.

R2 Delegate: - Jenny: No R2 report this month.

Vice Chair Report: None. THIS POSITION IS STILL OPEN.

WSO Delegate – **Agnes:** Agnes attended the Zoom World Service Business Conference. The meeting had technical difficulties and was fraught with issues. She will submit a complete report next month. Highlights were:

WSO budgeted \$700K for the meeting but got 920K, and accepted money from the Cares Act which was disputed as a tradition violation by some at the meeting.

All literature shall now refer to "higher power" and "god" in lower caps. This motion was brought by a literature subcommittee and passed with 2/3 majority vote.

There will be major changes in handouts - ex.: Dignity of Choice and Eating Plans will be merged as one pamphlet in the future.

Many people at WSO were upset and felt like the changes blindsided them.

Focus Groups having a national board rep became an issue – many conference attendees were upset because they felt like special interest groups were controlling the program. Agnes was so discouraged by the event she does not care to continue as WSO Rep in the future. (NOTE: Also please see Korie Beth's 5/7/2021 email to IG and Delegates for update re future literature changes by WSO.)

Young Person's Meetings Report - Patti O: Thanked the IG for starting the virtual YP meetings which will now be taken over by the YOUNG PERSONS VIRTUAL INTERGROUP (YPVIOA). Our IG was an integral part of getting this YPVIOA worldwide. Patti is currently advising the YPVIOA.

- All the ZOOM and phone meetings I have initiated in my position as Young Person's Outreach chair for the FIG would be taken over by the YPVIOA.
- The YPVIOA only has influence over virtual meetings (ZOOM and phone meetings).
- As the FIG had zero Young Persons Face to Face meetings when I took on the position, there would not currently be any meetings for me to moderate.
- Now it is my understanding the Young Persons Outreach chair position was not intended to be a
 moderator of meetings. I just did that because we didn't have any young people to run the initial
 Monday night phone meeting I started or the additional 5 phone meetings we added when we
 went into quarantine.
- If at some point the FIG Young Persons Outreach chair position changed to only be involved with the ZOOM and phone meetings I initiated then, yes, there would be no need for the Young Persons Outreach chair.
- If the position has stayed the same as when I took on the position, then the FIG could retain the Young Persons Outreach Chair position to address when we go back to Face to Face meetings

and to act as a liaison between the FIG and the YPVIOA and the Foothill community (school districts, youth events, etc.,).

Korie Beth and the Board congratulated Patti on her hard work and initiative. Sandy gave Patti O info re SGVIE's (San Gabriel Valley Inland Empire Intergroup) hybrid meetings.

Newcomer Chair – Liz: She's been working diligently with Sandy to solve the iPhone issue. They feel like the iPhone 5 is no longer useful for our efforts. They are switching to Ooma – a virtual voicemail box which will be a lot easier to monitor but give the same access to newcomers. She'll have more information next month.

12-Step Within – Marilyn: Nothing to report; kind of quiet. Hoping to work with someone on special 12-step within events, but more on that next meeting.

- Marilyn R-D reported that Saturday 8:30 am did change to Internet On-Line meeting.
- Cynthia submitted someone's name to Korie Beth for the workshop
- Korie Beth suggested that all who are interested in steps workshop should email her (KB) directly
- Liz confirmed she's interested in the Step workshop.
- Sandy: Since we changed our oa.org meeting designation, we have had out-of-state visitors participating in our Tuesday noon meeting
- KB said that Australian's are attending her meeting as well since changing designations.

Old Business:

- Agnes and KB report on double-winner meeting (OA Meeting for AA's). Agnes asked KB who
 followed up with WSO and the felt it would violate the singleness of purpose. Margaret will
 check with a friend of hers regarding double winner meetings. KB said that we can discuss
 further if people want to. Patti O suggested having a weekly special event for OA members with
 AA issues.
