George would like Sandy to post a document on our website announcements page that helps explain transitioning to online meetings published by WSO.

Vice Chair: Jenny – Jenny is finding the online meetings to be difficult. She hasn't been able to go on site and talk to people with everything going on.

WSO Delegate: Agnes – World Service Business meeting was cancelled. There are things happening online but she isn't following it. WSO will be refunding all that have registered \$49.

Public Info: Diane – She wasn't able to do anything related to OA this month. She will call her committee this month to see if/how we can do outreach in our current context. She would like to contact meetings to see if they are fiscally sound and will contact WSO to see if Intergroup can support them.
