Motion made by Michael and seconded by Heather K to accept new people into positions. It was passed unanimously.

Reminder about Bylaws – Diane motioned that we adopt the bylaws that Sandy has most recently reviewed and if we need to make adjustments, we should make them in the new year. Melinda seconded it. It was passed unanimously. Cynthia motioned that in January the committee will report back to take about any changes that were made. Pattie seconded it and it was passed unanimously.

New Intergroup Representative Guide – Cynthia: Cynthia sent a copy of the guide to everyone. Korie Beth motioned that this document become part of the Policy and Procedures document and get sent out to new reps. Marilyn seconded the motion and it was passed unanimously. Marilyn recommended to send it out to all meetings as a recruiting tool.

Secretary - Ashley: Margaret motioned to approve the minutes from last month as corrected and Heather seconded it. It was passed unanimously.

Treasurer – Susan: \$420 received from 7th tradition and \$55 from the Body Image Workshop. Total expenses were \$327. YTD profit is about \$1,700. Jenny motioned to approve the treasurers report and Michael seconded. It was passed unanimously.

Susan will need to present the audit of FIG treasurer's records at the January meeting. The audit went well – there were no mistakes. She will also present the budget for 2021 at that time. Susan will get in touch with Michael, the new treasurer.

Special Events – Melinda: Unfortunately, Melinda was unable to organize a holiday event this year. She reached out to San Fernando Intergroup about how they did their bingo and it was a lot more involved than she realized. Melinda is planning a January event along the lines of “Things I wish I knew when I joined OA” with speakers providing tips. She is currently looking for speakers and asked the intergroup to ask their fellows at their meetings. She is also looking for help to form a committee.

Melinda recently got a job and needs assistance to host events. She is looking for a co-chair.

Website Chair – Sandy: Lots of events are coming in and they are being posted on the website. She encouraged fellows to send her announcements of events that they might hear about. The website looks fabulous!

Public Events – Diane: Diane will be sending out literature and offer them a virtual information meeting. If there is enough interest, she will try to get a speaker following WSO format. This will go out at the end of December. She will also create a flyer to invite fellows to potentially be speakers.

The Spanish webpage is coming together beautifully. Diane will begin to work on the Policy and Procedure manual once she gets a final copy of the bylaws (without the red/blue text edits).
